B. DECLARATION OF LIABILITY AND ASSUMPTION OF RISK

By signing in Section D, each Active Participant (or their legal representative, if the person is under 15 years of age) confirms the following:

- (1) **I have read, understood, and agree with:** all provisions of the General Terms and Conditions of Visit to the NOD Activity Park, available on the website [www.nodpark.com] and at the park reception; the nature of the activities, the associated risks, and the safety restrictions on participation (age, safety reach, weight); the Rules for Visitors (Document B), available at the reception and on the website.
- (2) **I declare and undertake that:** the participant to whom my signature relates will take part in the mandatory Safety Training on the practice area and will not begin the activity without the instructor's express permission; that they will, throughout active use, act carefully and responsibly in accordance with their psychophysical abilities; that they will immediately stop the activity if fear, panic, uncertainty, or technical problems occur, and will call the instructor.
- (3) **I expressly acknowledge that I am aware:** that the activities in the park are inherently risky and are classified as adrenaline sports, and that I voluntarily accept the possible risks, which include falls from height and contact with obstacles that may cause bodily injury, disability, or death; that the instructor is not continuously physically present with every individual — the park relies on responsible conduct in accordance with the instructions received.
- (4) **I confirm,** that none of the participants to whom my signature relates is under the influence of alcohol, drugs, or substances that could affect judgment.
- (5) **To the fullest extent permitted by applicable law, I waive** the right to assert claims, damages, and lawsuits against the operator NOD, pustolovski park d.o.o., its representatives and employees, for any bodily injury, damage, or death resulting from the normal, expected risk of activities in the park. This waiver does not exclude the operator's liability for damage caused by gross negligence, intent, or breach of contractual obligations.
- (6) **I assume full material and criminal liability for my declaration.**

 HEALTH RESTRICTIONS — Entry to the courses is prohibited under the influence of alcohol/drugs.

I confirm that I have been expressly warned about (1) the list of psychophysical requirements and health restrictions set out in the General Terms (e.g., cardiovascular disease, spinal conditions, pregnancy, etc.) that preclude safe use of the park, (2) that, in the case of health conditions (such as allergies) or chronic illness (e.g., diabetes, high blood pressure), I must ensure that each individual participant has properly managed, stable regular therapy and brings with them any medication/inhalers and other aids they need, and (3) the obligation to consult with the instructor in advance in the case of mobility impairments or psychological disorders affecting any participant. I confirm that the above contraindications do not apply to any of the participants to whom my signature relates, unless expressly disclosed to the instructor upon check-in.

C. NOTICE ON THE PROTECTION OF PERSONAL DATA (GDPR)

By signing in Section D, I confirm that I am familiar with the provisions of the **Privacy Policy** (available at www.nodpark.com and at the park reception), which sets out how the operator collects and processes the personal data of all persons listed in Section D (including the personal data of participants under 15 years of age), the purposes for which it processes them, how long it retains them, and the rights of individuals regarding the protection of personal data.

D. PARTICIPANT DETAILS AND SIGNATURES

For participants under 15 years of age:

The declaration is signed by the legal representative. A companion who is not the legal representative must have an express written authorization from the legal representative and, by signing, assumes full responsibility for supervising the minor.
