PART 1 — DECLARATION OF LIABILITY AND ASSUMPTION OF RISK

By signing this form I confirm the following:

(1) I have read and accept: all provisions of the General Equipment Rental Terms and Conditions of NOD, pustolovski park d.o.o., available at www.nodpark.com and at the Park reception; the condition of the Equipment at handover as recorded in the table above; the Equipment rental price list.

(2) I declare and undertake: to use the Equipment responsibly and in accordance with the Operator's instructions; not to sublet the Equipment or permit its use by persons not listed on this form; to immediately cease use and notify the Operator's Authorised Representative in the event of malfunction or damage; to return the Equipment undamaged by the agreed deadline and at the agreed location.

(3) I acknowledge that cycling and recreational activities in nature involve inherent risks (falls, collisions, unpredictable terrain) which I voluntarily accept; that the Operator is not liable for injuries arising from failure to comply with the General Terms or improper use of the Equipment.

(4) I confirm that I am not under the influence of alcohol, drugs or any substances that would impair my ability to safely operate the Equipment, and that I am physically and mentally capable of doing so.

(5) To the fullest extent permitted by applicable law, I waive any claims, damages or legal action against the Operator NOD, pustolovski park d.o.o. for any bodily injury, loss or death arising from the normal, foreseeable risks of recreational activities. This waiver does **not exclude** the Operator's liability for damage caused by gross negligence or wilful misconduct.

(6) I assume full responsibility for the Equipment from the moment of collection until its return to the Operator. In the event of damage, loss or misappropriation I will reimburse the resulting loss in accordance with the General Terms.

⚠ KEY RESTRICTIONS — (a) Rental and use are prohibited under the influence of alcohol, drugs or psychoactive substances. (b) Minimum age of Renter: 15 years; for younger Users a legal guardian or Accompanying Person must sign and assumes full responsibility. (c) Prohibited: modifications to Equipment, subletting, and continued use of damaged Equipment.
